### CONSIDER BEING A PART OF OUR ORGANIZATION

Founded in 1972, the USAWOA was incorporated as a not-forprofit association in Virginia on 7 November 1974, and in 1985 became a charter member of The Military Coalition (TMC). The three words in the association's logo predominantly define its mission of advocacy on behalf of the Warrant Officers in all three components of the Army: Professionalism, Representation, and Recognition. The founders of the USAWOA saw the Warrant Officer Corps of the early 1970s as a disjointed group of technical experts with little or no standardization in the area of professional development and sought to change this.

From the beginning the USAWOA has worked within the Army system to encourage the development of an evolving system of standardized professional development for Warrant Officers to complement their superior technical knowledge and skills with increasing levels of leadership development. Simultaneously, it developed and encouraged sources of recognition of Warrant Officer excellence both inside the association and throughout the Army.

TMC provided the USAWOA with tremendous resources as a result of its newfound confederation with other military service organizations, with which it pooled their combined resources and influence. This gave the USAWOA the ability, through the TMC, to expand its representation of its members into the legislative arena. The results were astounding, achieving multiple legislative victories in the advance-

ment of Warrant Officers in multiple areas including: education, pay and allowances, commissioning, W5 paygrade authorization, and development of Secretary of the Armychartered Senior Warrant Officer leadership.

The USAWOA's philosophy has always been that recognition gained is directly proportional to value added. Every one of its members can be proud that its brief history of little more than 40 years - has decisively impacted a remarkable four-decade evolution of Army Warrant Officers into the indispensable cohort of professional, technical, commissioned Leaders that they are today. To this day, the USAWOA remains the only military service organization thoroughly devoted to the welfare of Army Warrant Officers -serving, former, and retired and their families.

# Member of the Month: CW5 Bill Langford



Chief Warrant Officer Five William (Bill) Langford joined the Army on 26 June 1975 and joined the Texas Army National Guard with the 249th Signal Battalion in Dallas, TX in September 1984. As an enlisted Soldier, Mr. Langford rose to the rank of MSG prior to being selected as a Warrant Officer Candidate.

Upon completion of WOCS, he was assigned as the OIC of the Branch Management Personnel. In March 2000 he was selected the State Physical Security Manager where he remained until May 2009, he then was selected as the 176th Engineer Brigade HR Tech from May 2009 thru August 2011 and was deployed to Sharana Afghanistan. Upon his return from Afghanistan in August 2011 his next duty assignment was the Senior Branch Manager of Officer Personnel while being assigned to JFHQ from August 2011 until September 2013. Since October 2013 until present CW5 Langford is the

JFHQ's Executive Officer and Officer in Charge of the JFHQ's HHD Full Time Staff.

When asked why he wanted to become a Warrant Officer, Mr. Langford stated that "I met my first Warrant (CW4) Officer in 1976 in Augsburg, Germany, I was a SPC at the time. I observed how he handled situations and how knowledgeable he was that put a spark in my step about Warrant Officers. I believe I had and still have so much to offer not only the Texas National Guard, NGB and the US Army, I wanted to ensure that not only junior Warrant Officers as well as NCOs have the right mentoring. Although being appointed in 1999, I first wanted to become a Warrant in 1991, at that time they didn't allow AGR NCOs become a Warrant Officer. I take being a Warrant Officer very seriously, I'm very passionate about my craft, many people misunderstand my passion as being arrogant or being something else." I asked Mr. Langford to provide some advice for the more junior members of our cohort. He provided the following: before taking the easy way out of asking a question to a Senior Warrant Officer always look in the regulation first., before advising anyone whether senior, peer or junior always know the correct answer. Lastly as the Commander's staff and the SME, the Commander expects that the Warrant Officer is a straight shooter, don't ever sugar coat your answers to the Commander, CofS, General Officers, etc. They may not like the answer you provide but will respect the heck out of you for your honesty.

Chief Warrant Officer Five Langford and his wife of 10 years, Virginia Lake of Brownsville, Texas reside in Austin, Texas. They have a total of six children, Chief has 3 daughters and Virginia has 2 daughters and a son. They also have nine grandchildren and one on the way.





## A Message from the Procurement Office

The Warrant Officer procurement office is still seeking qualified applicants to fill critical positions within the TXARNG. As Warrant Officers, WE are best suited to identify our replacements. If you have a qualified individual who meets the following criteria, encourage them to join our cohort.

- US Citizenship. (No Waivers)
- \* High school graduate or have a GED (No Waivers)
- \* FINAL Secret or Top Secret Security Clearance Interim clearances will not satisfy the requirement!
- \* Pass the standard 3-event Army Physical Fitness Test (APFT) and meet height/weight standards.
- \* APFT must be current and not older than six months by the time the applicants packet will be boarded.
- Pass the commissioning physical for technical specialties or the Class I (warrant officer candidate) flight physical for Aviators.
- \* All applicants must have 12 months remaining on their enlistment contract.
- \* Age Requirements: For 153A, 33rd birthday or less prior to their packet being boarded.
- \* For all other WO MOS's, 46th birthday or less prior to their packet being boarded.
- \* Applicants must submit an Age waiver request with the application if they exceed the age requirements specified.




